

COURIER SERVICE AGREEMENT

This **Courier Service Agreement** ("Agreement") is entered into on [July 11, 2006] between [SENDER'S NAME] ("Sender"), of [SENDER'S ADDRESS] and [COURIER'S NAME] ("Courier"), of [COURIER'S ADDRESS]. In valuable consideration thereof, Sender and Courier hereby agree as follows:

1. **INDEPENDENT COURIER RELATIONSHIP.** Sender hereby hires Courier, as the sole independent agent and employee of Sender, to deliver the items listed above to Recipient. Sender and Courier understand and agree that by means of this agreement, they are entering into an independent and private courier service relationship exclusive of any other party. The Casual Courier, Inc. ("TCC"), its owners, investors, and/or associates do NOT guarantee, warrant or insure the relationship between Courier and Sender, whatsoever.

2. **DELIVERY DATE.** Courier agrees to delivery items on behalf of the Sender on or before [DATE] ("Delivery Date"). In the even that the delivery will be delayed for any reason, Courier agrees to inform Sender promptly of the delay and request a reasonable extension of the delivery date.

2. **GOOD FAITH.** Courier agrees to deliver the Package in good-faith, to the best of his/her abilities, and with all reasonable efforts, to ensure safe transport of the Package to Recipient.

3. **SAFE CONTENTS.** Sender agrees, attests and affirms that the Package does NOT contain any harmful, dangerous, illegal, controlled, unlawful, forbidden or objectionable material, as defined by the US Transportation and Safety Administration (and listed at http://www.tsa.gov/interweb/assetlibrary/Permitted_Prohibited_5_16_2005_v3.pdf).

5. **PACKAGE DISCLOSURE.** Courier agrees to openly and clearly disclose Package contents when prompted by security and/or safety officers.

4. **OWNERSHIP.** Sender acknowledges that the Package, and each of its individual items and contents thereof, belong solely, exclusively, and legally to Sender, and that all items to be delivered by Courier are clearly and accurately enumerated above.

4. **EXAMINATION OF PACKAGE.** Sender and Courier agree that Courier thoroughly examined the Package in clear presence and view of Sender. Courier further agrees that the Package description

and contents listed above is accurate, and that the Package does not contain any harmful, dangerous, illegal, controlled, unlawful, forbidden or objectionable material, as defined above.

5. **DELIVERY FEE.** Sender agrees to pay Courier \$[**DELIVERY FEE**] upon successful delivery of the Package to Recipient ("Delivery Fee"). Payment of the Delivery Fee will occur on [**DATE July 11, 2006**] in the following form of payment:CASH.

6. **ESCROW PAYMENT.** In the event that payment is determined by the parties to be executed via online escrow payment, Sender agrees to provide Courier with the appropriate "Compensation Key" within 24 hours of confirmed package delivery to the following email address: [**E-MAIL ADDRESS**]

8. **DAMAGE/LOSS.** In the event that the Package is lost, damaged, or confiscated, by no fault of the Courier, Courier [WILL] be held liable for the value of the Package. All parties agree that in any event of loss, damage, and/or confiscation, for any reason, The Casual Courier, Inc., its owners, officers, investors, and/or associates do NOT guarantee, warrant or insure the relationship between Courier and Sender, and will NOT be liable for any damages incurred by or from this relationship.

7. **INDEMNIFICATION OF TCC.** Sender and Courier understand and agree that TCC and/or its associated website (located at <http://www.casualcourier.com>) are merely a "venue for information" and do NOT extend any warranty or guarantee whatsoever for courier or other services found via their website and/or other services. Courier and Sender agree to hold harmless and indemnify The Casual Courier, Inc., its owners, officers, investors, and/or associates, for any and all legal proceedings, and/or alleged liabilities, that may arise from the relationship between Courier and Sender, the transport of the Package, and/or this Agreement. Sender and Courier further agree to resolve and mediate any and all issues and/or claims relating to this Agreement and/or their relationship independently and agree NOT to involve, include, or implicate The Casual Courier, Inc., its owners, officers, investors, and/or associates in any way whatsoever. The use of the TCC's website and services is to be conducted at the users' sole discretion, responsibility and at the users' own risk.

The parties have executed this Agreement as of the date referred to above.
